CERTIFICATE OF MERIT

This involves Council members assessing each other. The outcome of this process is managed by the Secretariat and is confidential until the awards are presented. REGISTRATION COMMITTEE

At the inaugural meeting, it was confirmed that the opportunity for persons to register by review will be made available again. Please note that only landscape architects that graduated prior to 1994 are eligible to participate in this process. If you are aware of anyone who is not yet registered and eligible to register via this process please forwards this information to them.

In order to ensure that the process is dealt with in an efficient and effective way the following dates are to be noted:

- The intention to participate (completed application form) in this process by 1 October 2009
- Submission of the portfolios to the secretariat by 9th October 2009
- Anticipate interviews to be in the first week of November 2009, the date will be confirmed soonest.
