# **IDENTIFICATION OF WORK**

This process is continuing and we are hoping to complete the final draft for a last round of comment early in the New Year. The CBE is keen to obtain our finalised document so as to be able to submit the documentation to the Competition Commission. The anticipated date for gazetting the final documents is July 2009.

# **BUILT ENVIRONMENT PROFESSIONS BILL**

The controversial Built Environment Professions Bill has been withdrawn by newly appointed Public Works Minister Goeff Doidge. The objective of the Built Environment Professions Bill was to foster accelerated transformation of the professions and also proposes the establishment of a new South African Council for the Built Environment where all the existing professional councils would be incorporated as subsidiary boards. At a media briefing in Cape Town, Doige explained that a number of technical and legal details contained within the Bill overlapped and needed to be reworked before it could be tabled again in Parliament. SACLAP will continue its participation in the process and keep you informed.
