#### **SECTION 1:**

- It is moderated by an independent Registered Professional Landscape Architect i.e. someone that has not been involved in the process before prior to the examination.
- The exam is marked by the above stated panel.
- The marking is then moderated / checked by the moderator.

#### **SECTION 2,4,5:**

- The project profile will be evaluated by a panel of Registered Professional Landscape Architects
- It is moderated by another Registered Professional Landscape Architect once the panel has completed their process.

#### **SECTION 3:**

- The assignment will be evaluated by a panel of Registered Professional Landscape Architects
- It is moderated by another Registered Professional Landscape Architect once the panel has completed their process.

9	<b>PROFICIENT</b> : (practice orientated) An ability to demonstrate project based application of specialist knowledge, critically engaging with current research and or practices in doing so. To, within specific study fields, demonstrate the ability to apply appropriate methods and processes in unique real life project scenarios. To be proficient in management, design and supervision of project implementation in practice.			
7	<b>COMPETENT</b> : (field specific competence) Demonstrate knowledge of and project based engagement in an area at the forefront of a field, discipline and practice; relating that knowledge to a particular context. Selecting and applying appropriate procedures, processes and techniques to unique landscape related challenges within a specialized field of practice.			
5	<b>KNOWLEDGE AND UNDERSTANDING</b> : (integrated knowledge) the assimilation and comprehension of knowledge. Individuals should be able to understand, apply and evaluate the key terms, concepts, facts, principles, rules and theories within the working environment. The ability to select and apply a range of methods to resolve realistic landscape related problems in practice.			
3	<b>KNOWLEDGABLE</b> : (to be acquainted with) To demonstrate <u>detailed</u> knowledge of one or more fields, disciplines or practices including the ability to apply appropriate methods, procedures and techniques within a defined context.			
1	INFORMED AWARENESS: To be sufficiently informed on matters pertaining to the profession i.e. demonstrate a basic knowledge. Aided through experiential training and or industry related methods of learning.			

Going forward, candidates will have to meet the requirements in terms of the

new Registration Policy of November 2016.

# **Outcomes and Appeals....**

- It should be noted that:
  - In the case of Section 2,4,5, additional information may be requested after the submission date by the panel should it be necessary.
  - If there is any doubt in terms of the outcome, the individual may be called to an interview.
- The Registrar's Office consolidates all the outcomes received.
- These are presented to the Registration Committee for approval.
- The Registration Committee makes a recommendation to Council in terms of the outcome.
- It is anticipated that candidates will be informed of the outcome later in the year.

#### **APPEAL PROCESS**

- Once the outcome is made known the individual can lodge and appeal with SACLAP if he/she feels aggrieved. The details of this are set out in the Registration Policy.
- If the candidate is then still not happy with the outcome, after the SACLAP internal appeal process. An appeal may be lodged with the CBE.
