Report on the second quarter of the 2017/2018 financial year

1. COUNCIL AND GOVERNANCE MATTERS

1.1 Meet the new Council

1.2 Important milestones achieved since the previous Quarter

- The first and the second CBE Quarterly Reports have been submitted.
- The **Professional Registration Assessment Process** outcomes were made known at the end of August 2017. Well done to those who passed and are now professionally registered.
- The procurement process was undertaken for the **Registrar** to replace Bernadette Vollmer and her assistant Aso Balan. The process was concluded and SACLAP is happy to announce the appointment of Cecilia Chinga as registrar and Phindile Tsepetsi as her assistant.
- The 2017 2021 Council has been appointed and inaugurated on 20 October 2017.

2.5 Registration Policy & the Addendum for the Landscape Architectural Profession

In line with the new categories of registration with SACLAP, the following is to be noted:

- Candidate Landscape Architectural Technologists that have attained an Honours qualification are to please ensure that SACLAP has a copy of the latest qualification that has been received.
- ii. As a result of the new policy, the Professional Landscape Architectural Technologists (NQF 7) who qualify for upgrading to Professional Senior Landscape Architectural Technologists will be contacted in this regard. An upgrade process is being established and individuals will be advised of the necessary requirements and timeframes in due course.

SACLAP continues to register students (at no cost to the student), who are currently completing their studies in Landscape Architecture and Landscape Technology or other programmes relating to the professions. This allows students to remain up to date on SACLAP matters and in preparation for entry to the professional realm.
