SACLAP RATES TABLE FOR 2011/2012

NOTE: These prices are applicable from 1 April 2011 and will be reviewed in March each year to coincide with the financial year of SACLAP.

ONCE-OFF ADMINISTRATION RATE

The administration rate is applicable to any person that applies to be registered with SACLAP for the first time.

Candidate Landscape Architect	R300.00
Candidate Landscape Technologist	R300.00
Candidate Landscape Technician	R300.00
Candidate Landscape Assistant	R300.00

SACLAP ANNUAL REGISTRATION RATE FOR CANDIDATES

All candidates need to be registered with the Council for a period of two years.

Candidate Landscape Architect	R600.00 per year
Candidate Landscape Technologist	R550.00 per year
Candidate Landscape Technician	R500.00 per year
Candidate Landscape Assistant	R450.00 per year

A CBE levy, which is a statutory requirement of R27.00 (reviewed annually, await 2011 increase) will be added to the SACLAP rate.

SACLAP PROFESSIONAL EXAMINATION (IN MARCH OF EACH YEAR)

An examination rate is applicable. This rate is revised on an annual basis. Current rates are as follows:

Candidate Landscape Architect	R400.00 per paper
Candidate Landscape Technologist	R400.00 per paper
Candidate Landscape Technician	R350.00 per paper
Candidate Landscape Assistant	R350.00 per paper

These rates are applicable too if a paper is to be re-written.

The following re-mark rate is applicable should the candidate wish to have a paper re-marked. This rate is revised on an annual basis. Current rates are as follows:

Candidate Landscape Architect	R650.00 per paper
Candidate Landscape Technologist	R650.00 per paper
Candidate Landscape Technician	R500.00 per paper
Candidate Landscape Assistant	R500.00 per paper

REGISTRATION BY ALTERNATIVE MEANS

- i. Application by an individual to upgrade as set out in Registration Policy Document (applicable to all categories) R2200.00
- ii. Application by an individual by review as set out in Registration Policy Document R3500.00
- iii. Application by an individual with non SACLAP accredited or foreign qualifications as set out in Registration Policy Document R4000.00
- iv. Application by an individual with SA or foreign qualifications in a related professional field as set out in Registration Policy Document R4000.00
- v. Application by an individual with prior learning as set out in Registration Policy Document R4000.00

SACLAP PROFESSIONAL REGISTRATION RATE PER ANNUM

The annual registration rate for registered professionals is as follows:

Professional Landscape Architect	R2200.00
Professional Landscape Technologist	R1800.00
Professional Landscape Technician	R1400.00
Professional Landscape Assistant	R1200.00

A CBE levy, which is a statutory requirement of R42.00 (reviewed annually, await 2011 increase) will be added to the SACLAP rate.

PENALTIES

- i. Registration to sit the professional exam after 31 December of the year before the exam is to be sat in the March R1200.00 plus the administration rate.
- ii. Re-registration due to outstanding professional registration fees (provided CPD is up to date). Applicable if the 30 day term of payment of professional registration rates, as stated in the Act has not been made in time. R500.00 plus the administration rate.
- iii. Re-registration due to outstanding professional registration fees (provided CPD is up to date). Applicable if the 60 day term of payment of professional registration rates, as stated in the Act has not been made in time. R1000.00 plus the administration rate.

MISCELLANEOUS

- i. Replacement or duplicate copy of Registration Certificate R320.00 which will only be issued on receipt of payment.
